Foreign clients from the EEA and Switzerland :

National Card valid ID or valid passport
(photo likeness and signature of the holder)

Foreign customers outside the EEA and Switzerland :

Passport with valid student visa
(photo likeness and signature of the holder of Passport and Visa)

Or

**Residence Permit / Card resident / French residence permit
or EU valid**

(photo Likeness and signature of the holder)

If the identity document produced is not understandable
(non-Latin script), it must be asked, in addition to the original,
a second piece of identification or a certified translation of the document



IMPORTANT

- Must keep the account open for 1 year. Don't leave France without closing your bank account
- Which operations can you realize ?
 - Credit your account by placing your « CAF » payments, social welfare, wage if you have a job or an internship, foreign credit transfer to sustain and operate your french account...
 - Debit your account with transactions : rent, energy bills, cellphone, social welfare, payments and withdrawals with your credit card...
 - Check your account and operations on the Societe Generale App
 - Download your bank account statement
 - Contact your agency with the App



EQUIPMENT OF YOUR BANK ACCOUNT

- **Bank account identification (IBAN)**
- **« SOBRIO Services»:**
 - VISA CARD OR MASTERCARD : 6.50€/month - **Special offer → 1€/year**
 - Insurance which will refund the cost of your keys or identity papers if they are lost or stolen or of any fraudulent use of your payment means.
 - Exemption of fees for active account
 - A service that informs you in real time of the situation of your account.
- **Free APP* available on your mobile phone or tablet**

*(excluding the cost of the Internet service provider)
- **Student Home Insurance:**
 - Civil liability, fire, theft, flood, etc.
 - Round-the-clock home emergency assistance, 7 days a week.



PROOF OF ADDRESS



An original copy of a document (dating back less than three months) **recognized as proof of residence in France or abroad :**

Rent payment receipt, EDF/GDF bill, fixed-line telephone bill, etc.

If staying for Physical Person, 3 required documents are

- Certification of hosting up to 6 months + a copy of the identity of the host submitting the certificate (not required validity) + Proof of residence with the same address up to 6 months and the name of the signatory

If staying a Legal Entity or by the Administration

- Specialized Homes (young workers, etc.) University campus (students, researchers, etc.) are admissible. The certificate Accommodation must be less than 6 months and required notices are: address of residence, name and signature or stamp of the issuer, name and surname of the hosted.etc.)

If staying Self Catering (type AIRBNB)

- The proof (the receipt) provided must include all of the following elements: Contact information of the owner (name and phone) + The rental period in number of nights (including the arrival date and possibly the starting date) + The address of the rented accommodation + The rental confirmation code + The total amount of the rental.

If staying Clients staying at the hotel

- The certificate drawn up by the manager or the hotel manager is accepted as proof of residence provided that the customer receives his mail at the hotel
